सा.का.नि. 773(अ).—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और डाक एवं तार विभाग (मोटर, जीप, लॉरी और स्टॉफ कार डिंगइवर) भर्ती नियम, 1983, को, उन बातों के सिवाय, अधिक्रांत करते हुए, जिन्हें ऐसे अधिक्रमण से पूर्व किया गया है या करने का लोप किया गया है; डाक विभाग, संचार और सूचना प्रौद्योगिकी मंत्रालय में स्टॉफ कार डिंगइवर के पदों पर भर्ती की पद्धति का विनियमन हेतु निम्नलिखित नियम बनाते हैं, अर्थात् :—

1. संक्षिप्त नाम और प्रारंप -

- (i) इन नियमों का संक्षिप्त नाम डाक विभाग स्टॉफ कार ड⁸ाइवर (ग्रेड— I), स्टॉफ कार ड⁸ाइवर (ग्रेड— II) और स्टॉफ कार ड⁸ाइवर (साधारण ग्रेड) (ग्रुप ग पद) भर्ती नियम 2015 है।
- (ii) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।
- 2. पदों की संख्या, वर्गीकरण और देतन बैंड और ग्रेड देतन या देतनमान :- पदों की संख्या, उनका वर्गीकरण और देतन बैंड और ग्रेड देतन या देतनमान वे होंगे जो इन नियमों से उपाबद्ध अनुसूची के स्तम्म (2) से (4) में दिनिर्दिष्ट हैं।
- 3. भर्ती की पद्धित, आयु सीमा, अर्हताएं आदि :- भर्ती की पद्धित, आयु सीमा, अर्हताएं और उससे संबंधित अन्य बातें वे होंगी, जो उक्त अनुसूची के स्तम्म (5) से स्तम्म (13) में विनिर्दिष्ट हैं।
- 4. निर्श्हताएं वह व्यक्ति,-
 - (क) जिसने ऐसे व्यक्ति से, जिसका पति या जिसकी पत्नी जीवित है, विवाह किया है; या
 - (ख) जिसने अपने पति या अपनी पत्नी के जीवित होते हुए किसी अन्य व्यक्ति से विवाह किया है,

उक्त पद पर नियुक्ति का पात्र नहीं होगा :

परन्तु यदि केन्द्रीय सरकार का यह समाधान हो जाता है कि ऐसा विवाह, ऐसे व्यक्ति और विवाह के अन्य पक्षकार को लागू स्वीय विधि के अधीन अनुझेय है और ऐसा करने के लिए अन्य आधार हैं, तो वह किसी व्यक्ति को इस नियम के प्रवर्तन से छूट दे सकेगी।

- 5. षिथिल करने की शक्ति:— जहां केन्द्रीय सरकार की यह राय है कि ऐसा करना आवश्यक या समीचीन है, वहां उसके लिए जो कारण हैं उन्हें लेखबद्ध करके, इन नियमों के किसी उपबंध को किसी वर्ग या प्रवर्ग के व्यक्तियों की बाबत, आदेश द्वारा शिथिल कर सकेगी।
- 6. व्यावृत्ति इन नियमों की कोई बात, ऐसे आरक्षणों, आयु सीमा में छूट और उन रियायतों पर प्रभाव नहीं डालेगी, जिनका केन्द्रीय सरकार द्वारा इस संबंध में समय—समय पर जारी किए गए आदेशों के अनुसार अनुसूचित जातियों, अनुसूचित जनजातियों, अन्य पिछड़े वर्गों, भूतपूर्व—सैनिकों और अन्य विशेष प्रवर्ग के व्यक्तियों के लिए उपबंध करना अपेक्षित है।

NOTIFICATION

New Delhi, the 12th October, 2015

G.S.R. 773(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Posts and Telegraphs Department (Motor, Jeep, Lorry and Staff Car Driver) Recruitment Rules, 1983 except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of Staff Car Drivers in the Department of Posts, Ministry of Communications and Information Technology, namely:-

- 1. Short title and Commencement.—(1) These rules may be called Department of Posts Staff Car Driver (Grade-1), Staff Car Driver (Grade-II) and Staff Car Driver (Ordinary Grade) (Group C posts) Recruitment Rules, 2015.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. The number of posts, their classification and the Pay Band and Grade Pay or Pay Scale.—The number of posts, their classification and the Pay Band and Grade Pay or Pay Scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualifications etc.—The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the said Schedule.
- 4. **Disqualification.--** No person, -
 - (a) who, has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax .-- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving .-- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-serviceman and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
