In view of Judgment Order of Hon'ble Supreme Court and approval of Directorate for implementation of the Judgment, a Committee was constituted to work out strategy for segregation of the candidates as tainted and non-tainted. Accordingly, list of suspicious tainted candidates was published on 29.01.2021 vide letter referred above.

In the said list, total 73 candidates were declared as suspicious tainted whose signature variation was found and requested to submit their representation, if any by 19.02.2021. These candidates were further called to this office on 19.02.2021 for submission of Specimen Signature for onward submission to CFSL. The Signature specimen of these candidates was submitted to CFSL for further verification.

Accordingly, verification report of CFSL in respect of following three candidates is received. CFSL opined that Specimen signatures of these three candidates are similar with signatures on original attestation form but not similar with signatures on Original Admit Card and OMR Sheet.

Hence, as per the recommendation of the committee, above three candidates have been treated as 'Tainted' being cases of impersonation during the examination and their candidature is hereby cancelled on the basis of report from CFSL. (Candidates at Sl. No. 1 & 2 have been already treated as tainted vide this office Memo of even no. dated 12.03.2021).

Further, following candidate was also declared suspicious tainted vide letter referred above.

The candidate submitted her declaration dated 09.02.2021 about her mother tongue as Marathi. However, the candidate failed to submit copy of valid documentary proof in support of her claim of mother tongue as Marathi, despite of reasonable opportunity given to the candidates. Hence, the candidate Namrata Vilas Rodhe is treated as 'Tainted' and her candidature is hereby cancelled.
